- Administration is proud of the reputation and presence OCS maintains in the community as our school continues to grow and the student body continues to succeed despite financial challenges and supports organizations like PTO and OCS Athletics in their efforts to assist and support OCS.
- By the end of March, administration will have final report on enrollment figures for all grades.
- In grades K-4 ${ }^{\text {th }}$, there will be one classroom added to each grade for the school year 2016-2017. Administration is waiting for a minor modification request approval; a minor deviation from it's original charter approval.
- $7^{\text {th }}$ grade Greek Math has been temporarily suspended pending instructional solution; class period will be used for social studies research projects in interim.
