
#### Introductions of new board members

#### **Treasurer Report - Karen Thorpe & Riccardo Stoeckicht Innovative Schools**

- June 30<sup>th</sup> year end report (July to June 30)
- Ended up year 99.9% of revenue
- Federal fund reductions by end of year
- 97.2% of our budget
- state revenue –100% of what was budgeted
- we don't know our state revenue until after the September count
- funding from school district, local funds revenue building 26, S Thomas, after care, cafeteria
- federal funds title I & II, we were under at end of year they took away at end of year due to title I
- salaries came in 98 %
- benefits 98.1%
- contracted services 97% of budget (pretty typical)
- bus contract came in under budget
- cash balance \$1.3 million

Motion made to accept budget by Mike Kirifides, and 2<sup>nd</sup> by George Hantzandreou Passed.

Review of budget for next year (still working on it)

- Started to break out the budget into smaller budget within (facilities, food service, after care etc.)
- still a lot of unknowns, on local revenue side
- numbers from the district for revenue should be out within the next 7-10 days
- the September unit count drives the number from the state
- right now revenue is at \$18.5 million
- expenditures for salaries \$10.7 million(22.28% pension)
- contacted services \$2.5 million
- materials \$725k
- capital cost \$1.5 mil
- \$BMP/ST T (bond) \$2.4 million- debt services
- \$316,000 surplus in cash
- we also set aside \$120,000 for maintenance and repair
- 2<sup>nd</sup> tenant may be coming in next fall 2017 (building 27)
