



 - O Summer programs:
 - 1. Summer work has been distributed
 - 2. Supply lists are also posted
 - 3. PTO will create supply kits that parents can purchase
 - 4. Summer academic assistance:
 - a. Summer intensive academic assistance will be provided in August before the next academic year begins
 - Re-opening working groups are working on survey questions and working on scenarios for different options; DOE reports due July 15.
- Greek Program Report Dr. Marina Mattheoudakis
 - First grade students utilized a new Greek language learning app being developed in collaboration with the OCS and OCS faculty and students
 - On June 22nd, a widely broadcasted event hosted two of OCS first grade students and a teacher who shared their experiences with this language app with the Prime Minister of Greece
 - The students were invited by the Prime Minister of Greece to spend two weeks in Greece next year
- Campus Operations Officer report Presented by Riccardo Stoeckicht
 - o 2 vandalism incidents on the back of building 27
 - Destroyed 21 windows and 4 doors
 - Police have been informed and installed more cameras and widow breaker sensors that will trigger an alarm if anyone attempts to do it again
 - o \$20,000- \$30,000 likely damage
 - o B23 expansion:
 - 1. AIA133 agreement Commonwealth Construction Company
 - 2. Will launch the retrofit after the funding is released
