Review of minutes for March & April, Mary Lou made motion to accept, George Righos second, approved

Treasurers Report: Ted

- Based on cash flow of April 2014
- On line number 5/6 we paid off the Arch Diocese for the St Thomas (upper school) building, paid them \$482,000.
- Load from WSFS was for \$400,000 (the appraised value of building)
- New charge's were \$63,000 were for renovations on Building #20
- Mundy farm property was sold and we walked away with a \$55k + profit
- Was sold to Trinity Community Church
- Student transportation, custodial supplies, telephones, there seems to be a big fluctuation—how are we being charged?
  Buses are charged per day per bus, T1 line cost \$1000 per month

Advertising we spent \$3000 for March, was that for middle school? Enrollment, open house etc..

• Budget for next year? Final adjustments are being made, Peter is working out all the details.

• Some decisions need to be looked over on textbooks \$150,000, personnel, and sport programs for next school year

• George Chambers – the student need is paramount
