SCHOOL REOPENING OVERSIGHT COMMITTEE

On December 16th, the Board unanimously approved the hybrid, in-person reopening recommendations presented by Odyssey's Leadership Team as follows:

- Virtual learning will continue from January 4th to January 18th, 2021
- Flex Wednesdays will begin on Wednesday, January 6th, 2021
- A rollout of in-person, grade-level re-openings across our four schools, starting on January 19th.
- All complex, small group, extracurricular and other activities will also restart on January 19th.
- Staff teaching in grades starting on January 19th will return to school on January 14th to prepare their classrooms for in-person learning.
- All other staff will return on January 19th to support the reopening rollout. Should their own classes reopen later for in-person learning, they will teach virtually from their classrooms.

COMMUNITY OUTREACH

FOOD DRIVE/PANTRY

Paula Lowe and Eva Jannelli held another food drive and gave food boxes including turkeys to about 25 OCS families in November. In December, another 10 families were able to pick up food boxes. We also contributed to the FISH program at St. Paul's Church. Our pantry is an active donor to our community and since its inception earlier this year, we were able to serve many OCS families. BI-POLAR IONIZATION AIR PURIFICATION SYSTEM

In response to the COVID-19 pandemic, Odyssey Charter School installed a Bi-polar Ionization air purification system in buildings 20 (LS), 21 (MS), 22 (IS) and 23 (HS) at its Barley Mill Plaza campus. The \$130,000 system was incorporated in all roof top HVAC units. The installation process started on October 26 and was completed on November 6, 2020. The system covers all classrooms, hallways, small gym, cafeterias, and offices.

The HVAC upgrade cleans the indoor air safely continually and –

- Prevents mold
- Kills bacteria
- Kills viruses
- Has been tested against SARS-CoV-2 and was able to inactivate the virus

The roof top HVAC systems are configured to recycle the air throughout the buildings so the air is constantly being cleaned. The system does not require any maintenance and has a patent-pending self-cleaning design. The system comes with a three-year warranty. In addition to the new system, expanded HVAC preventative maintenance was also introduced to keep all HVAC units operating at peak condition. HVAC filters are being replaced on a quarterly basis.

We are also using an EPA registered antimicrobial surface protectant which, over the winter break, is being sprayed on surfaces in the classrooms and common areas. Once sprayed on a surface, this product will start to work as soon as microorganisms come into contact with it. The product can last on the sprayed surface for up to 90 days, but more frequent applications are being considered. Frequency of applications will consider the COVID-19 trends at school and in the County. This approach will provide an additional layer of protection for our students, faculty, and staff.

In addition to the HVAC improvements, the custodial staff will be performing the following daily tasks to help keep our students and employees safe –

- Cleaning and disinfecting all restrooms as per CDC guidelines every two hours or less
- Cleaning and disinfecting all common areas during the course of the day when students and staff are in school
- Cleaning and disinfecting students' desks during the school day
- Promptly removing breakfast and lunch trash outside of classrooms during the day
- Re-cleaning and disinfecting all classrooms after school hours
- Performing necessary floor maintenance after school hours
- Handling all trash removal and other cleaning needs as required

Every effort will be made to ensure a safe and clean environment for our students, employees and visitors.
