

 - Covid testing for staff and students
 - a. 90% of all OCS staff tested and on-site
 - b. 98.6% of attending students tested
 - c. 3 positive cases, <1%
 - >50% of students are planning to return for in person instruction
 - OCS is now a certified Covid testing center
 - Staff vaccinations have begun, and we work with the state's process
 - a. We will require testing once per month
 - o CDC physical distancing guideline remain, which limits return plans
 - o Testing for substitute teachers is also available and suggested



School Priorities

- o Fundraising 2.0, facilities updates
 - Flagpole fundraiser goal of \$80,000, look for details on how to become a permanent part of our school.
 - Working with the development team to meet with foundations and build a comprehensive plan to enrich our long term growth.
 - Finances are in great shape and we are on track for a surplus
- o Culture Focus we are analyzing our programs and structures
 - o Reviewing our grading, attendance, and other policies
 - o Commemorating the Greek bicentennial details will be coming soon
 - Celebrations for promotions of our students from grades K, 5, 8, and 12
 - a. Four graduation events this spring
 - o PTO Student store is opening
- o Review of next year's school course offerings, hiring's, and enrollment targets
 - Step Up Days for 8th graders accepted to visit the high school for one of three days of events. Each student who commits to OCSHS will receive a welcome kit, including swag and a class of 2025 t-shirt.
 - Invited 70 ninth graders, and have another 70 on the wait list
 - 68% of our class of 2021 are applying to college. 83% of those have been accepted to at least one college. Acceptances span 11 states.
 - The 2nd Youth Environment Summit is next week. In addition to OCS's Kanmani Duraikkannan, student leader of the conference, we have several other OCS student serving in key roles at this prestigious event.
 - o Spec Ed review is underway, including a new Spec Ed Director, Dr. DeMayo
- Visual Branding focus on visual, universal branding
 - First example is the enrollment and welcome kits
- Greek Program Dr. Marina Mattheoudakis
 - o Greek teachers participated in collaborative webinars with professors from Aristotle University to develop story based teaching for language and math
 - Feb 9th Greek Language Day students participated in day long activities
 - Feb 1 opens the application period for the summer program with Harvard University in Greece. One student each year has enjoyed this opportunity
 - Greece's Bicentennial is this year, we are putting together events celebrate Greek independence, and what independence means for our multi-cultural community
