

- 3. President Elias Rigas Took a moment to thank the students, staff, volunteers, and families of OCS unrelenting support of our school community through this pandemic to get us to where we are now.

  - Previous minutes 2/17 presented

    - Parent letter Questions regarding testing after spring break, and reasoning for the virtual week after break.
    - Parent letter Question regarding communications to parents when their child has been tested for Covid.
  - Head of School Report, Elias Pappas 90 Day Plan
    - Covid update on-site testing will continue to be available
      - Teacher vaccination update will be upcoming. There were events last weekend which gave staff the opportunity to get vaccinated. We will gather those stats. We are hoping for 85% vaccination by late Spring.
      - We have had 2 positive cases of Covid, which were able to catch and follow protocols to successfully contain, and prevent an outbreak.
      - High School 40% of the population is attending in person.
      - o Middle School 64% of our students are attending in person.
      - Intermediate School 57% of the population are back in the building.
      - Lower School 54% of our young learners have returned in person.
      - After Spring Break, we will require a covid test, as this will take at least 2-3 days to complete, we decided to be virtual, so we could ensure a safe return to in-person instruction.
      - We are reviewing changes from the CDC and our health data


Building #20, Barley Mill Plaza

- Fundraising the Flagpole initiative had begun. The goal is to raise over \$80,000. The brick can have family names or messages; information has been sent from the PTO. We are building the infrastructure to support a more cohesive approach to fundraising to address all our needs. This cloud based database will provide one source of information as we build the fundraising capacity.
- Culture Focus The gradebook polices for the middle and high school are being implemented. A parent education event after Spring Break will help explain how this will enable us to target individual learning needs and provide support.
  - The diversity and inclusion workshops for the leaders is continuing, 2 of the 6 sessions have been completed
  - March 11<sup>th</sup> we hosted a meet-and-greet with stakeholder, families, and our school support team. 50 families attended, another in coming in April.
  - In an effort to increase communication across the school, our support teams are attending faculty meetings to provide updates, answer questions, and maintain transparency.
  - Greek Independence Day celebrations will occur around March 25<sup>th</sup>, look for more details of all the events.
  - We will host 4 graduation events this year for students completing grades
    K, 5, 8 and 12. These milestones will be marked in early June.
  - PTO Student Store will open shortly
- High School Update College applications submitted by our seniors, 183, with
  71% applying to at least 1 school. Merit scholarships of over \$1.1 million has been offered to 30% of our students.
  92 acceptances in 12 states.
  - Admitted students visited the school for our first "Step Up" day. The event highlighted what sets our school apart, and gave them a chance to see it in person.
  - High School Principle Ashley Lipson introduced Jackie Brandt to report on our Business Professionals of America chapter members who competed in various events with other Delaware high school students. OCS students brought home BPA Student of the Year, several other awards and certifications.
  - High School Senior Nidhi Patel, the BPA Student of the Year, thanked her chapter and their support staff. It was an honor to shine as an Odyssey Owl in both the program and the competition.
  - We are proud of our BPA groups in the high school, and the middle school.

- Student Services Vision, Recovery, and Audit has begun and will proceed to help our teachers assure all our students' needs are addressed
- The attendance policy is in the final revision focusing on supporting our families. The updated grading policy is also moving forward.
