

      - Odyssey Charter Covid Dashboard presented as of 10/20
        - a. Mitigating strategies are proving to be successful
        - b. Testing is now every other week

      - Campus totals YTD 59 positives, 25 positives found with campus testing
      - We are delivering live instruction to quarantined students on a case-bycase basis. Reach out to your building leaders for details.

      - Vaccination and testing protocols from the DHSS will be implemented
    - Fundraising the Flagpole Fundraising. The funds from this fundraiser have been allocated to create the flagpole courtyard, new signs on the 4 buildings, new field branding, new recess equipment, a new scoreboard, and bleachers. We have committed \$55k with a goal of \$80k.
