

  - Over 196 staff tested so far, of 225. 5-6 positive across all staff.
  - Students and Staff are self-reporting positives status as well
  - Nurses are stressed trying to pull together the data
  - 4% of the students were positive in Quidel testing
  - Testing will continue, we will know more on Tuesday.
  - What virtual options are available? We have 1:1 technology, but much of that tech is in school not at home right now, particularly in the lower school.
  - Masking, expanded lunch space, and social distancing will continue
  - If we need to return to live cameras in the room, we can pivot quickly
  - Omicron surge may require the hybrid model, but kids need to be back in the classroom as quickly as we can.
  - Some schools are virtual all month, but nearly all are returning.
