


- Head of School Report Elias Pappas
  - Covid update Please don't send a sick child to school.
    - Odyssey Charter Covid Dashboard updated as of 2/16
      - a. Campus totals positive cases last week were down to 18
      - b. Campus totals year to date, 581
      - c. Quidel will continue to test our staff and students alternating buildings each week
    - o Culture update
      - a. PLCs will take place each month with each department to discuss survey results, feedback, and steps to improve.
      - b. Student survey have been returned and the data analyzed
      - c. Meetings have been held with EPP Alumni regarding support for our LGBTQ+ community, staff, and families.
      - d. Parent Camp will meet for the first time on March 2nd
    - o Lower School
      - a. SEL program collaborating with our Student Services Department and our occupational therapist to survey and begin classroom observations to bring restorative practices and zones of regulation to every classroom.
