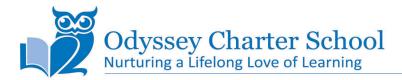

- d. School tours continue on Wednesdays.

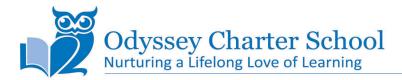
Middle school

High school

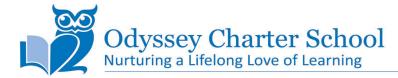
- a. College acceptances continue to roll in, 40 universities in 20 states

- Transportation
 - a. February our fleet ran at 99.996% on-time
 - b. Total of 900 routes with only 3 busses more than 10 minutes late
- Student Services
 - a. ACCESS for ELLs testing are complete, scores in mid-May
 - b. MTTS is being restructured for next year to better support students
 - c. Summer Learning Leap will identify students who will need support
 - d. Transition fair for students with disabilities will be March 24th at The Chase Center
 - e. March 21 is National Down Syndrome Day, and a mismatched sock fundraiser netted \$425 for Delaware Down Syndrome Association

 - Jeff Koss Preliminary Budget discussion
 - o Enrollment numbers 1,198 student, slightly above planned
 - o Transportation revenue reduces as we removed Red Clay routes
 - o Revenue budgeted per student reduced
 - Grant for transportation and food services
 - Decreased medical services
 - o Food expense rose as meals prepared increased
 - o Motion to approve FY22 final budget report as presented. PB 1st and EA 2nd
 - Approved unanimously
 - Jeff Koss Purchase authority request
 - Used bus purchase 3-4 used 2019 busses, \$72-75,000 each. Financing may be done through Santander. The request is only for the \$1,000 deposit for each bus to ensure delivery in June so they can be ready for August.
 - Chromebook refresh FY22 \$160,000, expecting the same for FY23. Payment not required until delivery
 - Athletic trainer contract FY22 \$45,000, contractor has a candidate available for 40 hour employment rather than the 20 planned. Contract payment not required until FY23. This is for the expanding sports program.
