



 - o Create more consistency regarding our uniforms in a post-Covid era
 - K-5 Shirts embroidered with school logo are to be navy, light blue, or white. Pants, shorts, skirts, and skorts are to be khaki, navy, or clear blue plaid. Jumpers with white blouse.
 - 6-12 Shirts embroidered with school logo are to be navy, light blue, grey, or white. Pants, shorts, skirts, and skorts are to be khaki, navy, or clear blue plaid.



- PE Plain, solid navy mesh shorts or sweatpants are the only bottoms students are permitted to wear, including spirit wear.
- Shoes Shoes must be closed toed, hard soled, and have a back. Sneakers, boots, and dress shoes are acceptable. Uggs, slippers, and crocs are not permitted.
- Socks Solid color only, no patterns or designs.
- Blazer To give our school and students a professional and more successful look for special events or visitors, we are proposing the addition of a navy blazer for scheduled professional days. Standard blazer from any retailer like Target, H&M, Gap, Old Navy, Walmart, etc. A sew-on patch to be affixed if not ordered through the school vendors. Loaners will be available and we will fundraise and utilize the Owl Fund to assist families with financial needs.



- Cell phone policy
 - Cell phones present an indisputable impediment to learning, and we have the research backs this up. Social media, messaging, and filming are major contributing factors to behavioral infractions, attention spans, and mental health.
 - Removing all cell phones and connected watches at Odyssey during the school day will enable us to maximize instructional time, allow students to become critical thinkers, and successful social interactions
 - Cell phones must be powered off and in students backpack or locker, not in clothing pockets from boarding the bus or arriving by carline
 - \circ $\;$ Emergency calls or contacts would be make through the front office
 - \circ $\;$ Devices can be powered on once the student returns to their guardian.


